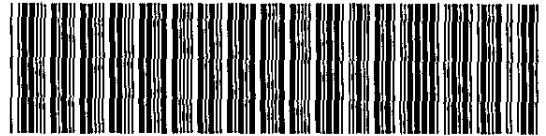

ARTICLE I

NAME:

PURPOSE:

The corporation is organized to engage in all business permitted under
the laws of the State of Florida.

ARTICLE III

CAPITAL STOCK:

The maximum number of shares of stocks which this corporation is

At each election for Directors, cumulative voting by shareholders as set forth in Florida Statutes, Chapter 607.097 (4) shall be allowed.

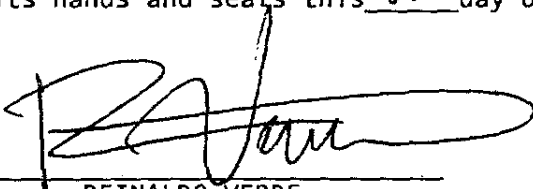

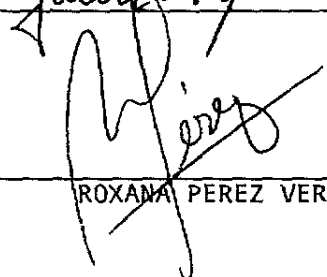
AMENDMENT:

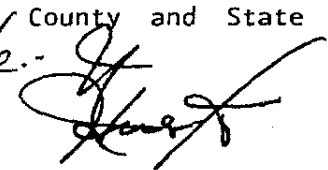

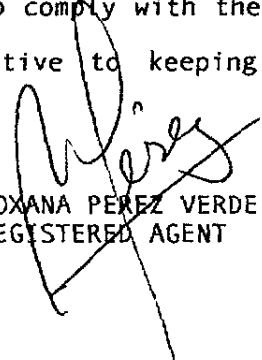
