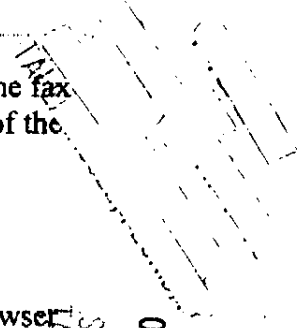



Stock Certificate: The stock certificates of the corporation will be in the form attached hereto.


