Article VI. The election of the following individuals to the office or offices of the corporation described below are hereby ratified, such individuals to serve until their successors are duly elected and qualified:

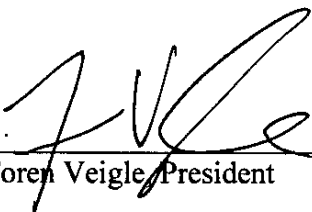

5. The foregoing amendments were approved by the shareholders of the company. The number of votes cast for the foregoing amendments by the shareholders was sufficient for approval.

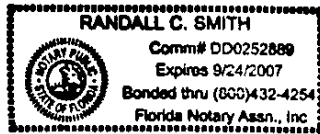
