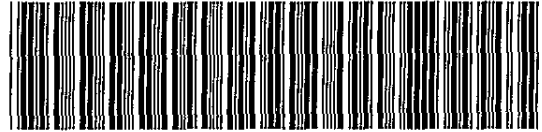

ARTICLE I - NAME. The name of this corporation is MASTERY ONE, INC.

ARTICLE II - PRINCIPAL OFFICE.

ARTICLE III - DURATION. This corporation is to have perpetual existence beginning with the date of subscription and acknowledgement of these Articles of Incorporation which is the 7<sup>th</sup> day of February, 2006.

ARTICLE IV - PURPOSE. This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE V - CAPITAL STOCK. This corporation is authorized to issue 5,000 shares of common stock at \$1.00 par value per share.
