I, THE UNDERSIGNED, hereby come forth for the purpose of becoming a corporation under the Laws of the State of Florida, by and under the provisions of the Statutes of the said State of Florida.

ARTICLE I

The name of the corporation shall be: AFFORDABLE PRO VIDEO OF SOUTH FLORIDA, INC.
Its business shall be carried on in the State of Florida, in the United States
of America, and elsewhere, as may be authorized by the Board of Directors.
