ARTICLES OF INCORPORATION

OF

ADAM J. RINGLER, D.P.M., P.A.

PREAMBLE

Adam J. Ringler, Esquire, being duly licensed to practice medicine under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation and Limited Company Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I. NAME

The name of the professional service corporation is "Adam J. Ringler, D.P.M., P.A."

ARTICLE II. PRINCIPAL OFFICE

The principle off and mailing address of this corporation is 777 East 25th Street, Suite 302, Hialeah, Florida 33013.

ARTICLE III. PURPOSE

The professional service corporation is formed to engage in every phase and aspect the practice of podiatry.

ARTICLE IV. TERM OF EXISTENCE

The professional service corporation shall have perpetual existence commencing March 10, 2006.

ARTICLE V. CAPITAL STOCK

The capital stock of the professional services corporation shall be 1,000 shares of common stock with a par value of \$.10. None of the shares of the professional services corporation may be issued to anyone other than an individual duly licensed to practice medicine in the State of Florida.

ARTICLE VII. REGISTERED AGENT

ARTICLE X. RESTRAINT ON ALIENATION OF SHARES

The shareholders of the professional service corporation shall have the power to include in the bylaws, or by separate agreement adopted by a majority of the shareholders of the corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer, or other disposition of any of the outstanding stock of the corporation by any of its shareholders, or in the event of the death of any of its shareholders, The manner and form, as well as the relevant terms, conditions, and details, of the disposition shall be determined by the shareholders of the corporation; provided, however that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the ownership of such stock. No shareholder of the corporation may sell or transfer stock in the corporation except to another who is eligible to be a shareholder of the professional services corporation, and the sale or transfer may be made only after it has been approved at a shareholders' meeting especially called for that purpose. If any shareholder becomes legally disqualified to practice medicine in the State of Florida, is elected to a public office, or accepts employment that places restrictions or limitations on the continuous rendering of such professional services, that shareholder's shares of stock shall immediately become subject to purchase by the professional service corporation in accordance with the bylaws adopted by the shareholders.

ARTICLE XI. AMENDMENT

The corporation reserves the right to amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.
