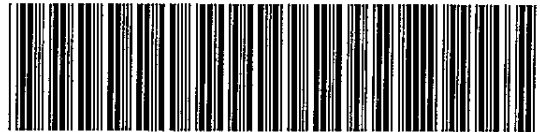

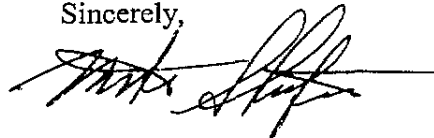

ARTICLES OF INCORPORATION OF
DAVID & RHONDA BUCKNER, P.A.

1. The name of this Corporation is **DAVID & RHONDA BUCKNER, P.A.**
2. The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida. The purposes for which this Corporation is organized includes the purpose to arrange for the trade, purchase and sale of real property, and to act as agent for others who want to accomplish the same.
3. The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock, having a par value of \$1.00 per share.
4. This Corporation shall have perpetual existence commencing upon filing of these Articles.
5. The Registered Agent and the street address of the initial registered agent of this corporation in the State of Florida shall be: RHONDA J. BUCKNER, 3200 SE 20th Avenue, Ocala, FL 34471, who by signature herein is accepting designation as Resident Agent.
6. The initial stockholders will be as follows:

David L. Buckner & Rhonda J. Buckner, 100 shares, joint tenants with right of survivorship

Shares held by each shareholder may not be sold or otherwise transferred to other persons or other entities, except as follows: a) sold back to the corporation at a price agreed to between the seller and the remaining shareholders, or if no price is found agreeable then at a price as determined by an independent appraiser; or b) devised by will to either a surviving spouse, or lineal descendant; or c) to any third party after written consent to such conveyance by a majority vote of the remaining shares of stock. The price, terms, and other provisions regarding this restriction may be specified by written agreement among the shareholders, which agreement may expand this Article. No share shall be conveyed, split, transferred, or given by testamentary devise or otherwise, if such action would violate the federal prescriptions for an S corporation, as provided by law in effect at the time of proposed action.

7. The initial offices and officers shall be as follows:

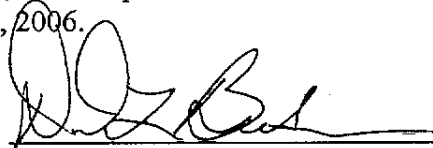

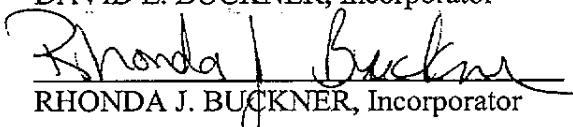

8. The business of this corporation shall be managed by the stockholders of the corporation, rather than by a Board of Directors.

10. The names and principal street address of the persons signing these Articles of Incorporation as the incorporators are: DAVID L. BUCKNER and RHONDA J. BUCKNER, 3200 SE 20th Avenue, Ocala, FL 34471.
11. This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation, by a simple majority vote of the outstanding shares of stock.
12. The principal place of business shall be 1918 SE 17th Street, Ocala, FL 34471.
13. Both the President and the Vice President, acting in their sole capacity, have the authority to sign contracts, checks, receipts and otherwise conduct business on behalf of the corporation.

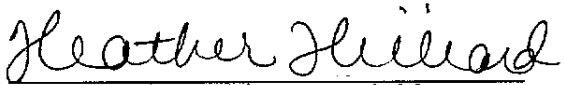

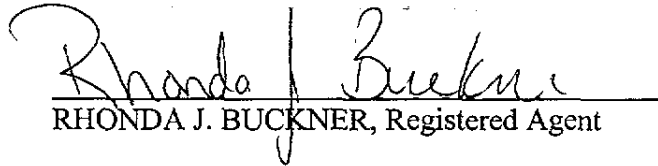
