Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendments to its Articles of Incorporation:

#### ARTICLE 1 NAME

The name of the corporation shall be TOWER HILL SIGNATURE INSURANCE COMPANY. For convenience, the corporation shall be referred to in this instrument as the "Company." These Articles of Incorporation as the "Articles" and the Bylaws of the Company as the "Bylaws."
