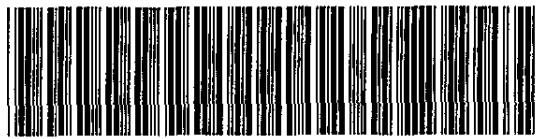

ARTICLE I. NAME

NAME: The name of this corporation is MOM'S WAY CLEANING, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the 14<sup>th</sup>  
day of April, 2006.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of providing professional cleaning services for commercial, industrial or private purposes and for the general public. The corporation is authorized to transact any and all other lawful business in the State of Florida and the United States of America.

ARTICLE IV. CAPITAL STOCK
