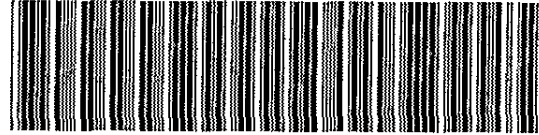

Article I

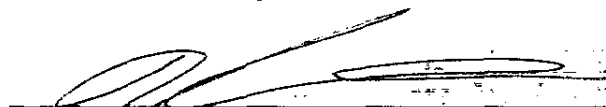
Name

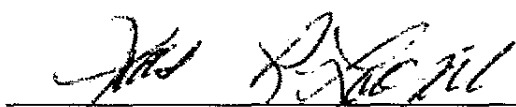
