1. The Articles of Incorporation of the Corporation are hereby amended to provide that the name of the company shall be as follows:

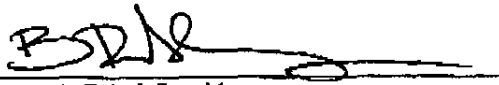
Make It Fit America, Inc.
