ARTICLES OF INCORPORATION OF FLORIDA

ARTICLE I: NAME

The name of the corporation shall be: -Pebblebrooke Animal Hospital, Inc.

ARTICLE II: DURATION

The term of existence of this corporation is perpetual.

ARTICLE III: PURPOSE OF THIS CORPORATION

This corporation is organized to engage in, or transact the business of a Veterinary Hospital and all business activities related thereto, and all other lawful business and/or activities for which corporations may be incorporated under the laws of the United States of America, The Florida General Corporation Act, the State of Florida, and/or any other state, country, territory, or nation.

ARTICLE IV: PRINCIPAL OFFICE

ARTICLE V: CAPITAL STOCK

ARTICLE VIII: INITIAL BOARD OF DIRECTORS

The corporation shall initially have one (1) Director, which may be increased from time to time through appropriate changes in the By-Laws, but the number of Directors shall never exceed Five (5) Directors. The initial director shall be Arthur Newman, who shall be President and Secretary.

ARTICLE IX: GENERAL PROVISIONS

- (A) The private property of the stockholder(s) shall not be subject to the payment of any corporate debts to any extent whatsoever.
- (B) Subject to the provisions and conditions of this Article, the corporation shall have the full power and lawful authority to accept property, labor and services in payment for shares of its capital stock in lieu of cash, at fair market valuation to be fixed by its Board of Directors.
- (C) A Director and/or Officer of the corporation may transact business, borrow, lend or otherwise deal or contract with the corporation to the full extent and subject only to the limitations and provisions of the laws of the State of Florida and laws of the United States of America.
- (D) The corporation shall indemnify each director and officer of the corporation against all or any portion of any expenses reasonably incurred by him/her in connection with or arising out of any action, sult or proceeding in which he/she may be involved, by reason of he/she being or having been a director or officer of the corporation [whether or not he/she continues to be a director or officer at the time of incurring such expense(s)], to the full extent permitted by and subject only to the limitations and provisions of the laws of the State of Florida and the United States of America.

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) these Articles of Incorporation.
