ARTICLE I. is altered, amended, and changed to read as follows:

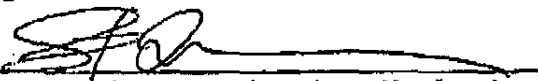

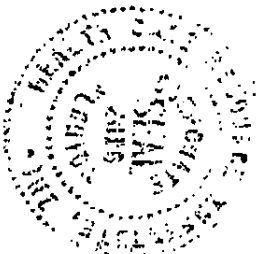
