ARTICLES OF INCORPORATION

OF

PADRON'S DOLLAR CORPORATION

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is PADRON'S DOLLAR CORPORATION.

The duration of the corporation is perpetual.

The general purposes for which the corporation is organized are:

1. 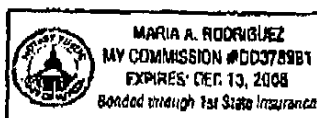




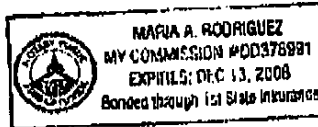
