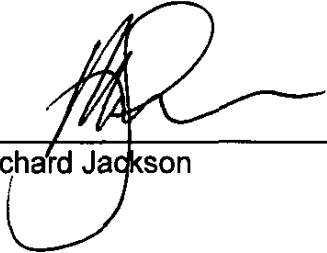
ARTICLE VIII - Amendment of Articles
