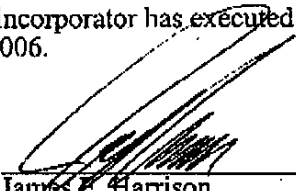
ARTICLE IX - INDEMNIFICATION

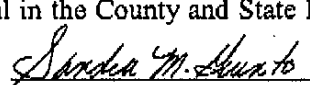

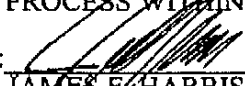

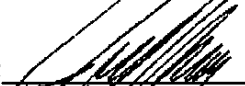
