ARTICLES OF INCORPORATION
OF
NEW JET ACQUISITION CORP.

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is New Jet Acquisition Corp.

SECOND: The street address, wherever located, of the principal office of the corporation is 1100 Wilson Boulevard, Suite 3000, Arlington, VA 22209. The mailing address of the corporation is the same as the principal office address.

THIRD: The number of shares that the corporation is authorized to issue is 1000, all of which are of a par value of \$0.01 dollars each and are of the same class and are Common shares.
