BY-LAWS

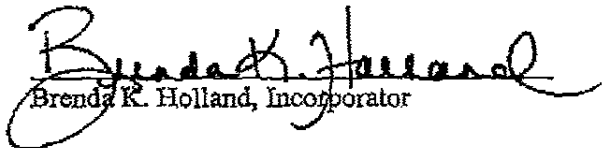

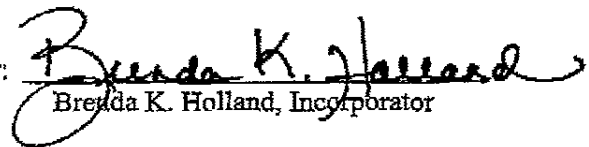

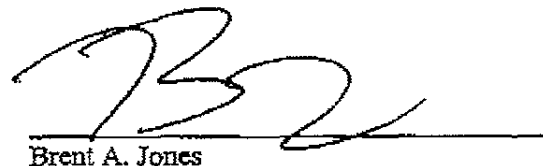
