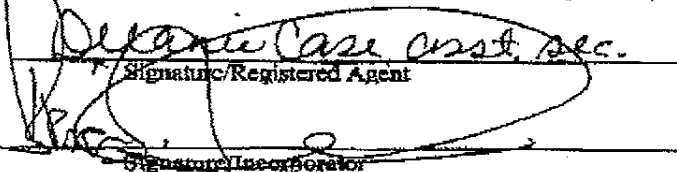

ARTICLES OF INCORPORATION
OF CNA METALS MIAMI EXPORT, INC.**

ARTICLE III PURPOSE
