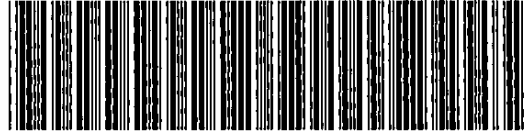

CUMULATIVE VOTING:

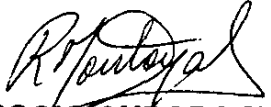

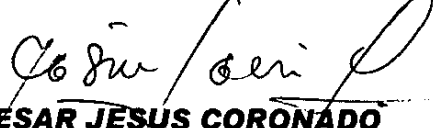
