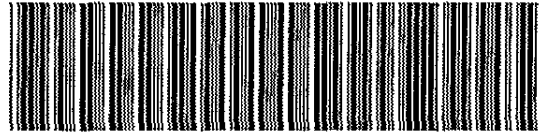

ARTICLES OF INCORPORATION

of

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby the following Articles of Incorporation

ARTICLE I - NAME

The name of the corporation shall be: GURU TOYZ INC.

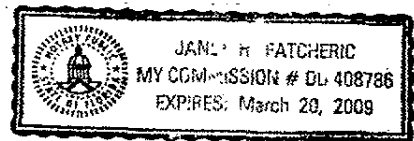
