The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE 1

Name

The name of the corporation is Parolise & Schieren, INC.

ARTICLE II

Principal Office

The principal office and mailing address of the corporation shall be 1817 Pleasantview Drive E, Jacksonville, Florida 32225-2115.

ARTICLE III

Duration

This corporation shall exist perpetually.
