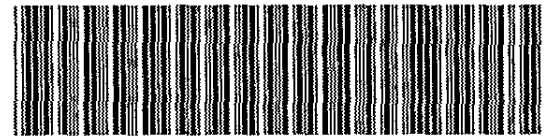

ARTICLE I. NAME

The name of this corporation is
WM C. SCHARRINGHAUSEN, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.


