ARTICLES OF INCORPORATION SECRETARY OF STATE OF TALLAHASSEE, FLORIDA OF See Habla Salsa. com, Lorporation

The undersigned, acting as incorporator of a corporation under the Florida Statutes, adopts the following Articles of Incorporation:

FIRST: The name of the corporation is Se Halba Salsa.com, Covporation
