ARTICLES OF INCORPORATION OF OANA MIERLOI, D.D.S., P.A.

The undersigned, who, if a natural person, is eighteen years of age or older, hereby establishes a corporation pursuant to the Florida Business Corporation Act, as amended, and adopts the following Articles of Incorporation:

Article I. Corporate Name

The name of this corporation is Oana Mierloi, D.D.S., P.A.

Article II. Duration

The corporation shall have an immediate effective date upon the filing of these Articles with the Florida Department of State.

Article III. Purpose

The corporation is organized for the specific purpose of offering dental services by a licensed dentist. The corporation shall have and may exercise all the rights, powers and privileges now or hereafter conferred upon corporations organized under the laws of Florida as a professional service corporation.

Article IV. Capital Stock

The corporation is authorized to issue One Hundred (100) shares of stock, all of which shall be voting common shares with a par value of \$1.00 (one dollar). All stock when issued shall be fully paid for and shall be nonassessable. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. Shares shall only be issued to a party who qualifies to be a shareholder under the terms of Fla. Stat. sec. 621.11.

Article V. Designation of Registered Agent and Office


