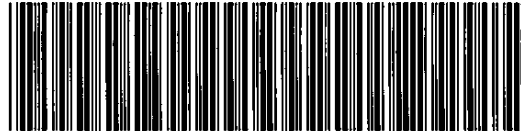

ARTICLES OF INCORPORATION
OF

CARIBBEAN MEAT MARKET CORP.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation is:

Shareholders shall not be entitled to preemptive rights.

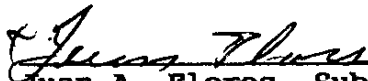

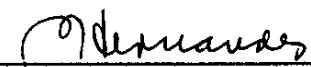
