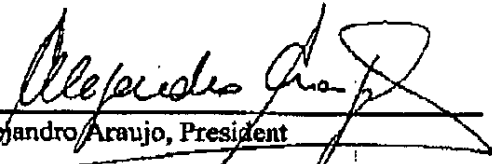

Fourth: This amendment was adopted by the officer and director without shareholder action and shareholder action was not required.

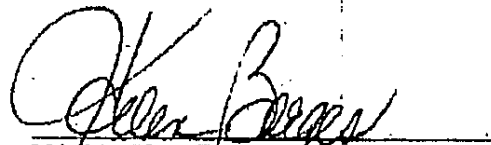
