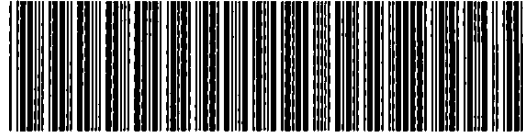

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: G PUBLISHING 2, INC.

**ARTICLE II**

The existence of the Corporation shall begin on: December 6, 2006.

**ARTICLE III**

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 100, par value \$100.00 per share, all of which shall be Common Shares. 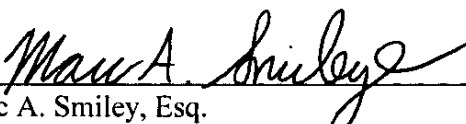
