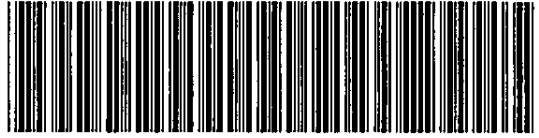



OF

ARTICLE I. NAME

The name of this corporation is HUSKY SERVICES, INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 2007, and shall have perpetual existence.

ARTICLE III. PURPOSE





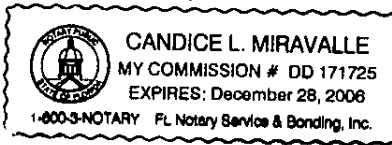
