FIRST: The undersigned, Edward Hand, whose address is 1574 Village Square Boulevard, Suite 100, Tallahassee Florida 32309, does hereby adopt the following Articles of Incorporation for the purpose of forming a professional corporation (hereinafter called the "corporation") in the State of Florida, under the Professional Service Corporation and Limited Liability Company Act, Chapter 621, and the General Laws of the State of Florida.

<u>SECOND</u>: The name of the corporation is Frank D. Hosley, P.A.

THIRD: The purposes for which the corporation is formed are to engage in every phase and aspect of the business of rendering the same services to the public that a licensed attorney, under the laws of the State of Florida, is authorized to render, and to engage in any other acts that are permitted by law.

<u>FOURTH</u>: The post office address of the principal office of the corporation in Florida is Two Alhambra Plaza, Suite 800, Coral Gables, Florida 33134 and the mailing address is the same.

FIFTH: The name and the post office address of the resident agent of the corporation in Florida are: Atrium Registered Agents, Inc., 1500 San Remo Avenue, Suite 125, Coral Gables, Florida 33146.

SIXTH: The corporation has authority to issue 500 shares of stock, all of which shall have \$1.00 par value and classified as Common Stock.

<u>SEVENTH</u>: The initial number of directors of the corporation shall be one which number may be increased or decreased pursuant to the bylaws of the corporation; and the name and address of the director who shall act until the first annual meeting or until their successors are elected and qualify are Frank D. Such indemnification provided shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any bylaw, Agreement or Resolution adopted by the shareholders entitled to vote thereon after notice.

<u>TENTH</u>: The duration of the corporation shall be perpetual. The effective date of this filing shall be January 1, 2007.
