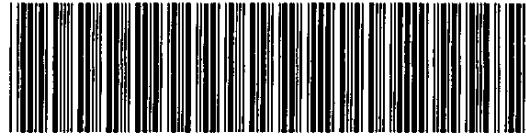

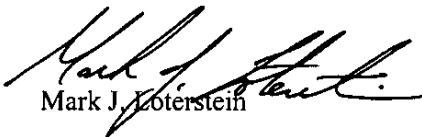

**ARTICLES OF INCORPORATION  
OF  
JPA INTERNATIONAL INVESTMENT, INC.**

SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

The name of the corporation is **JPA International Investment, Inc.** (hereinafter "Corporation") whose principal place of business is **2455 East Sunrise Blvd., Suite #1103, Fort Lauderdale, Florida 33304.**

**ARTICLE II**

The period of duration of the Corporation is perpetual.

**ARTICLE III**

The purpose or purposes for which the Corporation is organized are to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE IV**

The Corporation shall have the authority to issue one thousand (1,000) shares, all of one class of Capital Stock, with a par value of \$1.00 per share. All holders of shares of common stock shall be identical with each other in every respect. 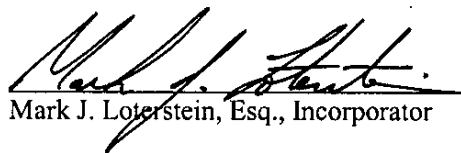
#### ARTICLE IX

The corporation shall indemnify its directors, officers, employees and agents to the fullest extent permitted by law.

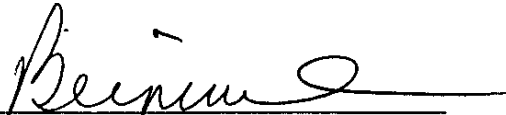


