The undersigned, acting as incorporator of 4 CORNERS CAR WASH, INC., adopts the following Articles of Incorporation to form a for profit corporation under the laws of the State of Florida.

**ARTICLE I
NAME**

**ARTICLE III
COMMENCEMENT AND TERM OF EXISTENCE**

The existence of the corporation will commence at 12:01 on the date of filing these Articles of Incorporation and shall continue perpetually.

**ARTICLE IV
NATURE OF BUSINESS**

The purpose of the corporation is to engage in the following business activities:

1. Engage in the activities of a retail car wash business, both self-service and automatic touchless, and related services and products, together with other and ancillary businesses.
2. Any other lawful activity permitted under the laws of the state of Florida.

**ARTICLE V
CAPITAL STOCK**

The maximum number of shares that the corporation is authorized to have outstanding at any one time is 1,000,000 shares of common stock having a par value of \$1.00 per share.

**ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT**

BOARD OF DIRECTORS**

The corporation shall initially have one (1) director whose term of office shall not be for more than one (1) year after the date of incorporation, unless re-elected. All directors shall be United States citizens and all shall be over the age of 18. The number of directors may be either increased or diminished from time to time, as provided in the by-laws, but shall never be less than that required by law. 
