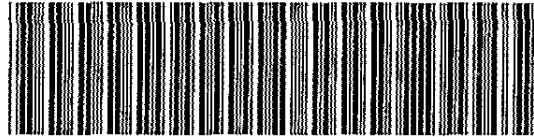

ARTICLES OF INCORPORATION  
FOR

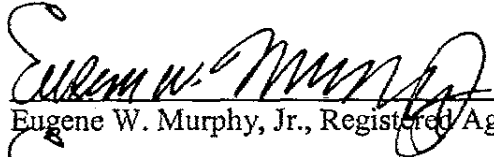

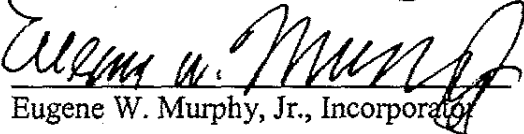
