ARTICLES OF INCORPORATION

OF

ARTICLE I

The name of this corporation is: NCC Business Services of America, Inc. The principal office of the corporation is located at 3733 University Boulevard West, Suite 300, Jacksonville, Florida 32217.

ARTICLE II

This corporation is organized for the purpose of transacting any or all lawful business permitted under the Laws of the United States and of the State of Florida.

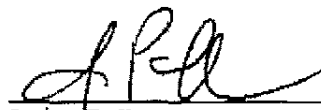
