## ARTICLES OF INCORPORATION OF ABERDEV US, INC.

The undersigned, being above the age of eighteen (18) years and competent to contract, for the purpose of organizing a corporation pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

#### **ARTICLE 1**

#### NAME

The name of this Corporation shall be ABERDEV US, INC., and its principal place of business shall be located at 12552 Park Avenue, Windermere, FL 34786.

#### **ARTICLE II**

#### COMMENCEMENT OF CORPORATE EXISTENCE

This Corporation shall commence corporate existence on the date of filing these articles of incorporation with the Secretary of State of Florida, and shall have perpetual existence unless sooner dissolved according to law.

#### ARTICLE III

#### **GENERAL PURPOSE: GENERAL POWERS**

- 4. <u>No Preemptive Rights.</u> No shareholder of the Corporation shall have the right, upon the sale for cash or otherwise, of any new stock of the Corporation or of any stock of the Corporation held by it in its treasury or otherwise, of the same or any other kind, class or series as that which he already holds, to purchase his pro rate or any other share of such stock at the same price at which it is offered to others or at any other price.

#### ARTICLE V

#### INITIAL REGISTERED OFFICE AND AGENT
