ARTICLE I. NAME

The name of this corporation shall be GREGORY A. HALL, ARCHITECT, P.A.

ARTICLE II. PRINCIPAL OFFICE

The mailing address and principal place of business of the corporation is 7739 Westmoreland Drive, Sarasota, Florida 34243.

ARTICLE III. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of signing of these Articles Of Incorporation. This corporation's duration shall be perpetual.

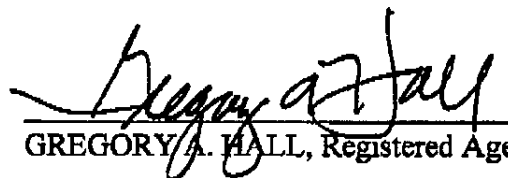
