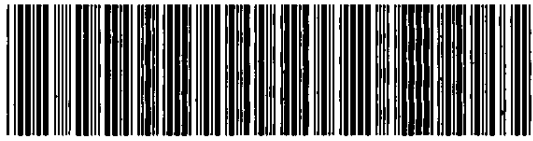

The only difference will be in the suite # 104-D new... 106-D old. So the new information will be

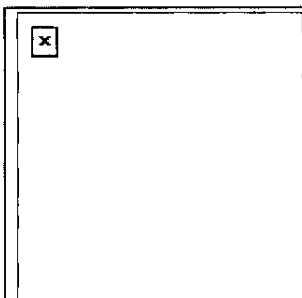
