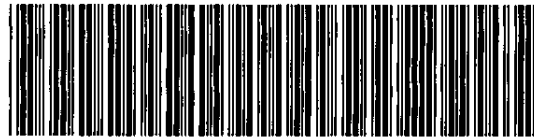

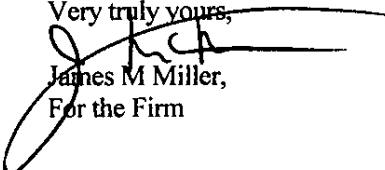

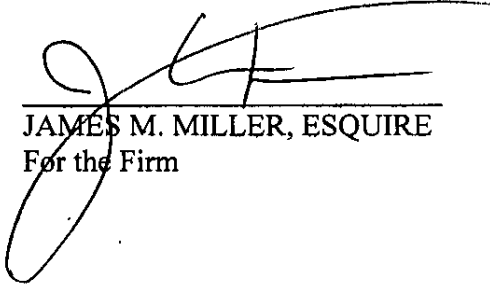

GLOBAL-WIDE TECHNOLOGIES, INC.

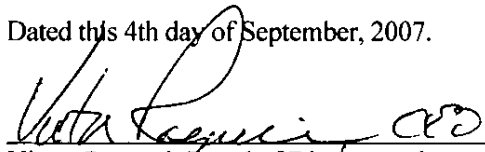
The change in name is the only amendment being made to the Articles of Incorporation. All other provisions of the original articles of incorporation remain the same.
