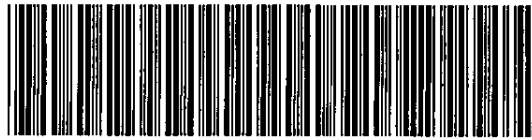

**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
BY OWNER MULTIPLE LISTING SERVICES, CORP.**

Pursuant to Chapters 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of **BY OWNER MULTIPLE LISTING SERVICES, CORP.**, a Florida corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is **BY OWNER MULTIPLE LISTING SERVICES, CORP.**


SECOND: **ARTICLE I. NAME** of the Articles of Incorporation is amended in its entirety as follows:

"ARTICLE I. NAME

"The name of the Corporation is **HOMEMART - BY OWNER MLS CORP.** (the "Corporation")."
