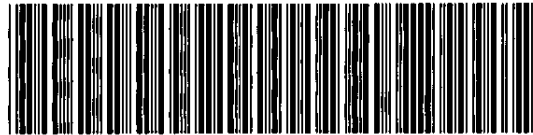

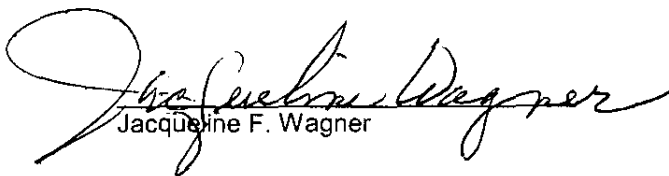

AMENDMENT

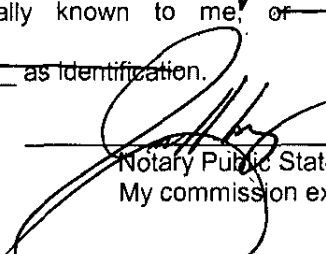
