The name of this Corporation is BRC Eatery, Inc. Its principal office address and business mailing address is 9330 SW 40 Street, Miami, Florida 33165.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

**ARTICLE IV - CAPITAL STOCK**

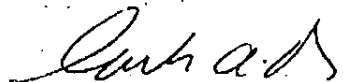

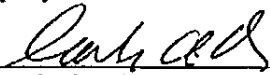
