The undersigned incorporator, KARL S. SELF JR., an individual authorized to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, *Florida Statutes*.

ARTICLE I - NAME

The name of this corporation is as follows:

ARTICLE II - PRINCIPAL OFFICE

The Initial address of the principal office of the corporation is 3930 Piedmont Road, Pensacola, Florida 32503.

ARTICLE III - PURPOSE




