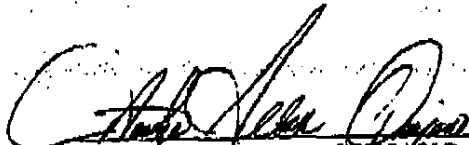
ARTICLE X-INCORPORATOR

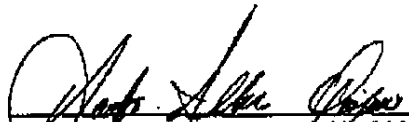
