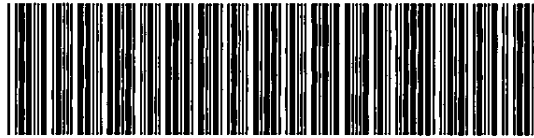

ARTICLES OF INCORPORATION
FOR
BRADDY & ASSOCIATES REALTY, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

**Name, Location and
Mailing Address of Principal Office**

The name of the corporation is BRADDY & ASSOCIATES REALTY, INC. The principal office and mailing address of this corporation is 2801 St. Johns Bluff Road South, Suite 4, Jacksonville, Florida 32246.

ARTICLE II

Purpose

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States and the State of Florida.

ARTICLE III

Capital Stock

This corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than 35 persons. Stock will be issued and transferred only to (i) natural persons, (ii) estates, or (iii) a trust defined in Section 1361(c)(2)(or its successor section) of the Internal Revenue Code. In addition, no stock shall be issued or transferred to a nonresident alien. The corporation is authorized to issue 500 shares of capital stock, of which 500 shares shall be issued to Darrell E. Braddy, each share having a par value of \$1.00.

ARTICLE IV

Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 2801 St. Johns Bluff Road South, Suite 4, Jacksonville, Florida 32246, and the name of the initial registered agent of the corporation at that address is Darrell E. Braddy.

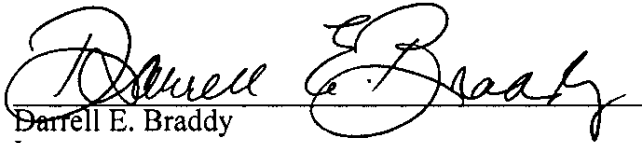
ARTICLE IX

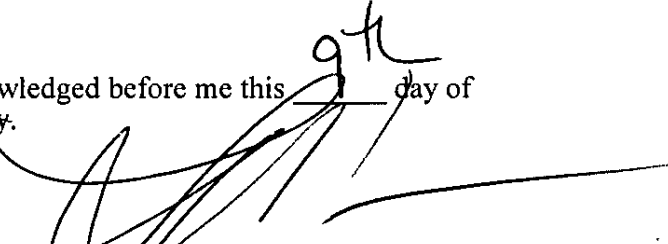
