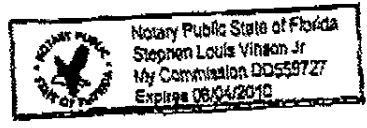

The undersigned, for the purpose of forming a professional association under the Florida Business Corporation Act and adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is Allison Adler, P.A. and its address is: 1865 N. Corporate Lakes Blvd., Suite 1, Weston, FL 33326.

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

Purpose

The general purposes for which the corporation is organized are:

(1) To transact any business as a mortgage broker/lender under the Florida Business Corporation Act.

(2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
