ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

Article 1. Name

The name of this corporation is Salcillo Properties, Inc.

Article 2. Principal Office

The principal office and the mailing address of the corporation is: 354 Sevilla Avenue, Coral Gables, Florida 33134.

Article 3. Duration

The period of its duration is perpetual. It shall commence its existence upon the filing of these Articles of Incorporation with the Secretary of State of Florida.

Article 4. Purpose

The purpose is to engage in any activities or business permitted under the laws of the United States and of the State of Florida.

Article 5. Capital Stock

The corporation is authorized to issue One Hundred (100) shares at Ten (\$10) Dollars par value.

Article 6. Initial Registered Office and Agent

The name and address of the initial registered agent and office of this corporation is as follows: Evaristo A. Ortiz, 354 Sevilla Avenue, Coral Gables, Florida 33134.

Article 7. Initial Board of Directors

This corporation shall have one director initially. The number of directors may be either increased or decreased from time to time by an amendment of the bylaws of the corporation in the manner provided by law, but shall never be less than one.

The name and address of the initial director of this corporation is: Andres Pintado Paredes, Avenida Gutierrez Mellado No. 9, Centrofama 30008, Murcia, Spain.

Article 8. Initial Officers

The initial officers of the corporation shall be: President: Andres Pintado Paredes; Secretary: Andres Pintado Paredes.

Article 9. Incorporator

The name and address of the incorporator is: Evaristo A. Ortiz, 354 Sevilla Avenue, Coral Gables, Florida 33134.

Article 10. Amendment of Articles

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders subject to this reservation.

Article 11. Pre-emptive Rights

Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares), of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized),

including shares from the treasury shares. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms, and inviting him to exercise his preemptive rights. The right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

Article 12. Removal of Directors

At a meeting of shareholders called expressly for that purpose, any one director, or the entire board of directors, may be removed, with or without cause, by a vote of the holders of the majority of the shares then entitled to vote at an election of directors.


Article 13. Indemnification

Article 14. Amendment

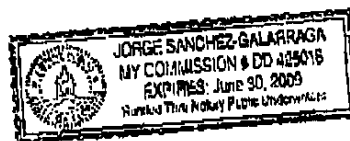
