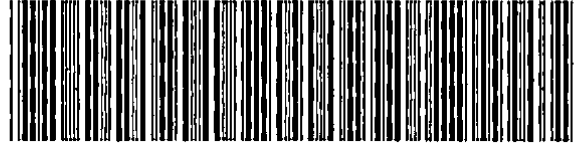

CERTIFICATE OF ORGANIZATION

Clay Electric Employees' CREDIT UNION.

We, residents of the State of Florida, whose names are hereto subscribed, do, by this agreement, associate ourselves together with the intention of forming a Credit Union, in accordance with the provisions of Chapter 657, Florida Statutes, 1941, and do hereby bind ourselves to comply with the provisions of this Certificate of Organization and with all laws, rules and regulations applicable to Credit Unions in Florida; and do hereby certify as follows:

(1) The name of the proposed Credit Union is the Clay Electric Employees' Credit Union. The business office of the said Credit Union is to be located in the city (town) of Keystone Heights, in the State of Florida.
