WE the undersigned for the purpose of becoming a corporation under the laws of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of corporations for profit, file these Articles of Incorporation.

ARTICLE I

The name of the corporation is

The general pature of the business or businesses to be transacted is as follows:

ARTICLE III

The foregoing clauses shall be construed both as objects and powers but no recitation, expression or declaration of specific or special powers or purposes herein snumerated shall be deemed to be explusive but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.


