The undersigned, acting as the Incorporator of THREE VIEW TECHNOLOGIES, INC., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

**ARTICLE I - NAME**

The name of the Corporation is THREE VIEW TECHNOLOGIES, INC. The street address of the initial principal office of the Corporation shall be 301 East Pine Street, Suite 1400, Orlando, Florida 32801. The mailing address of the corporation shall be c/o Dirk Heinrich, VisuMotion GmbH, Pruessingstrasse 35, 07745 Jena, Germany.

**ARTICLE II - CORPORATE EXISTENCE**

The Corporation will exist commencing as of January 1, 2008.

**ARTICLE III - DURATION**

The Corporation shall exist perpetually.

**ARTICLE IV - PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes.

**ARTICLE V - CAPITAL STOCK**
