ARTICLES OF INCORPORATION

OF

QUALITY WHOLESALE USED TIRES, INC.

ARTICLE I - NAME

The name of the corporation is Quality Wholesale Used Tires, Inc., at 1125 Dallam Avenue NW, Palm Bay, FL 32907 (Principal Office of Registered Agent).

<u>ARTICLE II - DURATION</u>

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".

<u>ARTICLE V - VOTING RIGHTS</u>

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

ARTICLE XIII - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
